NEW RESOURCE: Level Up Virginia Website Launched!

Virginians have a new tool to help them plan for their education after high school with a new website launched by the State Council of Higher Education for Virginia (SCHEV). The *Level Up Virginia* website provides information on educational options such as certificate programs, apprenticeships, the military, trade schools, two-year and four-year colleges, and universities. In addition, the website offers tips for adult learners, students with disabilities, first-generation students, and English language learners.

SCHEV has worked with high school counselors, students, and college access experts to ensure that the website meets the unique needs of Virginians. This statewide initiative with VDOE aims to increase postsecondary readiness, enrollment, and completion for all students in the Commonwealth. COLLEGE INFORMATION:

Fall was a very busy season in the CCC! College representatives from 98 colleges and universities visited WPHS between mid-September and early November this year and 1,076 seniors and juniors attended these visits. Students learned about different types of colleges from across the United States and what each has to offer prospective students. Some of the schools who visited included Yale, Dartmouth, Vassar, Purdue, Syracuse, Wake Forest, Vanderbilt, Georgia, Husson, Elon, Morgan, Berklee College of Music, SCAD, Champlain, and Iowa. Virginia schools were also well represented. Some of the visits included UVA, VA Tech, William & Mary, JMU, ODU, VCU, George Mason, Christopher Newport, University of Richmond, Randolph, Bridgewater & Northern Virginia Community College.

Seniors were also able to participate in "On-site Admissions Day in the Career Center". Representatives from Radford University and Mary Baldwin University provided on-site admissions decisions to seniors who pre-registered and completed their applications.

Updates in College Admissions:

Several Virginia colleges and universities have new initiatives to support students & their families throughout the college application process. The requirements vary by college. Additionally, there are certain majors and/or honor programs that have different admissions requirements. Students should go to the university website or contact the admissions office for answers to questions not available on the websites.

- Radford University will offer direct admission to prospective incoming freshmen and transfer students who meet the outlined criteria. Applicants will automatically be offered admission without committee review. For incoming freshmen some of the criteria includes a minimum weighted GPA of 3.3, passing grade in Algebra 2 and a completed/submitted application. - Virginia Commonwealth University guarantees admission to first year applicants who
 have a high school GPA of 3.5. Please note that guaranteed admission does not include

Apprenticeship 101:

FCPS Adult & Community Education (ACE) offers this program which prepares students for ACE apprenticeship classes in Electrical, HVAC and Plumbing as well as entry-level positions on project sites. Students learn the basics in safety, hand and power tools, construction math, material handling, construction drawings and employability skills. Participants can also earn an industry-recognized credential through the NCCER Registry System. The discounted tuition fee is \$197 (not including the \$35 textbook fee & \$5 lab fee). There are two upcoming sessions.

The Winter Session will be held at Woodson High School (9525 Main Street, Fairfax, VA) from 2/5/24 – 5/29/24. Sessions will be Monday & Wednesday from 6 pm -9 pm.

The Summer session will be held at Bryant High School (2709 Popkins Lane, Alexandria, VA) from 6/28/24 - 7/12/24. Sessions will be Monday thru Friday from 8 am - 3 pm.

NOVA Application Workshops: The NOVA application for the Fall, 2024 semester is open! Seniors can complete their applications at https://www.nvcc.edu/admissions/apply/.

Seniors will need to bring their computer, social security number or permanent residence number (if available), & questions. Students must also have a personal email account.

Seniors **ONLY** can sign up for this event via *Naviance/Colleges/College Rep Visits*. Registration **is** required. If attending one of the sessions held during the school day, seniors must speak with their Advisory teacher prior to the application session.

FINANCIAL AID INFORMATION:

ALL college bound seniors are strongly encouraged to complete their financial aid application to be considered for federal, state and/or college specific financial aid.

Free Application for Federal Student Aid (FAFSA) Update:

The FAFSA usually opens on October 1st; however, the opening date for the FAFSA has been delayed this year. The Office of Federal Student Aid has announced that the 2024-2025 FAFSA will open *by* December 31, 2023.

What does this mean for seniors & families when it comes to completing the FAFSA?

- Colleges & universities will be using 12/31 as the opening date for FAFSA.
- The date that FAFSA opens is <u>not</u> the financial aid deadline. Check individual college websites for each school's financial aid deadline.

- Because this is a new version of the application, financial aid experts are suggesting that families wait a few days before accessing the form, as there may be some 'bugs' for the federal government to work out.
- In addition, financial aid experts are communicating that a student's FAFSA data will be sent from the federal government to colleges in late January/early February, so there is no disadvantage to waiting a week or two.

What can a senior and parent(s) do now to prepare for FAFSA's opening?

- Create your FSA ID (FAFSA username and password). Both the student and parent/guardian will each need a FSA ID.
- Families with multiple students in college: Like the college application process where each student has their own application, each student in a family has their own financial aid application & will need an individual FSA ID to complete it.
- If a parent/guardian has a FSA ID from an older child, you do not need to create another. While student's need individual FSA ID's, parents use the same FSA ID for multiple children.
- Go to https://studentaid.gov/fsa-id/create-account/launch to create an account.
- There is a 3–5 day processing time for your account to activate. You do not have to wait until December 31 to create your FSA ID.

Virginia Application for Student Aid (VASA):

The VASA is used by Virginians who are nonimmigrants, undocumented, have Deferred Action for Childhood Arrivals (DACA) status or are otherwise ineligible to file the FAFSA and would like to be considered for state financial aid. Students who are unable to complete the FAFSA can use the VASA to access financial aid from Virginia.

- The VASA is scheduled to open sometime in January 2024.
- Students and families can visit the website if you are not sure which financial aid application to complete as well as to access the VASA once it opens.

College Access Fairfax (CAF):

College Access Fairfax is a free resource for FCPS students and families and available to answer questions about the financial aid process. Mrs. Rowsey is our *CAF* Financial Aid Champion. She is in the Career Center once a week to assist students. If help is needed, seniors can come into the Career Center during all lunches to ask questions and get assistance creating their FSA ID. Students will need to bring their computer and social security number. Appointments are not needed...just stop by!

WPHS FAFSA or VASA Completion Workshop on 1/23:

College Access Fairfax will host a FAFSA/ VASA completion workshop at the West Potomac High School Library on January 23rd from 6:00 pm – 8:00 pm. It is being offered to seniors and parents/guardians of seniors who may need assistance in completing the student's 2024-2025 FAFSA or VASA application. Registration is not required for this event.

What will be needed to complete the entire FAFSA at this event:

- Create an FSA ID (your FAFSA username and password) at least one week before the event.
- ➤ Both the senior AND parent/guardian should attend together.
- > Students MUST bring their FCPS laptop. (Personal laptops cannot connect to the FCPS Wi-Fi at the school)
- Needed Documents:
 - 2022 Tax Forms & wage statements (W-2, etc.)
 - Social security number for parents & students (or permanent resident number)
 - An FSA ID for both the student & one parent
 - Alien registration card (if not a U.S. citizen)
 - Date of birth of students & parents
 - Parents' date of marriage (and divorce, if applicable)
 - Date you moved to Virginia
 - Drivers license (if you have one)
 - Current statements for checking, savings, & other asset accounts
 - Current investment records, including 529 plans or other prepaid college plans
 - Military Families: LES (student and/or parents) for any month in 2022

SAT, ACT and PSAT TEST PREP:

Question: Do colleges still require the SAT or ACT test as an admissions requirement? **Answer:** It varies by college.

Class of 2024: While many colleges do not require the SAT or ACT as an admissions requirement, EVERY COLLEGE HAS DIFFERENT ADMISSIONS REQUIREMENTS and policies regarding standardized tests.

Classes of 2025, 2026, & 2027: Whether or not standardized tests will be required remains an open question for some colleges & universities. There are colleges that are currently test optional for the Class of 2024 but will re-evaluate their policies regarding standardized tests requirements for future graduating classes. Students will need to research this requirement during their college search process and before submitting their applications during their senior year.

Recommendation: We recommend that ALL college bound students take the SAT and/or ACT. Some colleges and scholarships require standardized test scores in the application process. Generally, students take the SAT and/or ACT for the first time in the spring of junior year. We recommend that students complete Algebra 2 prior to testing. If a student takes Algebra 2 during junior year, target the June official test date as the first test attempt. There are several ways to prepare for the SAT or ACT. For students who wish to prepare on their own, *Khan Academy* or *Kaplan Test Prep* are two great online resources.

For students who are interested in a test prep class, **Applerouth Test Prep** partners with our WPHS PTSA to offer test preparation at a discounted rate for WPHS students.
